Session 1: Taking off the lenses of insecurity to reframe transcontinental relations and migration management

On the occasion of the publication of the second paper of the FEPS Global Migration Group – focusing on increasing and strengthening orderly regular migration routes; better framing relations with both the African countries and African regional organisations in the field of migration management as well as development; and at converging fair and non-discriminatory standards and procedures in the EU labour markets that put people at centre stage – the Foundation for European Progressive Studies promotes a debate to discuss relations between Europe and Africa in the field of migration. These seems to be currently based largely on a securitarian approach, whose positive effect on both migration management and relations between the two continents is arguable.
